

## **RV GUIDELINES**

As an RV guest at ILNC, along with the current Code of Conduct, you are responsible for the following:

- Maintaining a minimum of four feet (4') between any item and your camper other than decks, as required by EGLE licensing guidelines.
- Keeping no more than two pets on your lot, keeping all dogs on 6' leashes when outside your RV, and collecting and properly disposing of any pet waste. Animals are not allowed inside any of the camp buildings, except service animals (specially trained to provide a specific service to their owner). All dogs and cats must have proof of rabies vaccine on file in the camp office. Any and all exotic animals (including but not limited to all sorts of snakes, lizards, alligators) are NOT allowed on camp property.
- Keeping noise at a respectable level, especially between 10 PM and 8 AM.
- Hooking your RV up ONLY to the power and water sources assigned to your specific RV lot. Please keep backflow prevention devices on the water spigot.
- Permitting ONLY LICENSED DRIVERS 16 years of age and older to operate vehicles (including and not limited to golf carts, ATVs, UTVs, motorcycles and mopeds). Posted speed limits and stop signs will be enforced. Vehicles and bikes out after dark may not be used WITHOUT proper lighting. Vehicles and bicycles must be driven on established roadways; DO NOT cut across lots or property. Speed limit across the campground is 10 mph.
- Ensuring ALL vehicles and trailers have proper vehicle registration and current tag. Any vehicle parked in undesignated parking may be towed at the owner's expense.
- Maintaining clean, organized, and presentable lots. You are responsible for keeping your RV lot mowed (not to be over 6"). Confine your belongings (cars, trucks, boats, etc.) and extended slide-outs to your assigned lot. Do not park at RV shower/laundry parking unless you are using the shower/laundry. The RV lot is NOT to become a storage lot and should not be cluttered with decorations and other items.
- Discarding trash properly in the dumpsters (not on the ground beside it) and not burning trash in your lot's campfire ring.

- Not bringing in firewood from outside of the camp (PROHIBITED to prevent the infestation of destructive pests and bugs), monitoring all campfires visually, and building campfires only in firepits. Firewood is available to purchase.
- Building any portable decks and similar structures so they can be easily removed, if needed. If you are a seasonal RV guest only (not paying the winter storage fee), you are also responsible for removing all items from the RV lot by the end of each season. If you do not you will be charged the winter storage fee.
- Cleaning up after yourself when leaving your assigned lot. Please leave your lot better than you found it!
- Possessing and/or using NO fireworks anywhere on ILNC camp property.
- Disconnecting water and power to your RV at the end of each season.
- Refraining from possession or use of alcohol, tobacco, cannabis, e-cigarettes/vapes or any illegal drugs/paraphernalia anywhere on ILNC property.

\*\*\* If you (or anyone else you allow to visit or use your lot) violate these guidelines, you may be asked to vacate property WITHOUT refunding of fees. \*\*\*
